19	On Monday, October 2nd, we		
20	recognized five recent graduates of the CERA		
21	Program, which is the nation's first		
22	professional certification program for election		

and voter registration professionals. Since 1994, the Election Center, in partnership with Auburn University in Alabama, has offered professional certification as Certified Elections Registration Administrator, CERA, status.

The Professional Education Program is the only program of continuing professional education which specializes in voter administration. registration and elections Participants receive continuing education units from Auburn University and Election Center credits achievement of toward the the profession's highest designation.

Our 2023 graduates are Melissa Alexander, Duan Jones, Randy Legette, Richard Thompson, and Ladawne White. Congratulations to our graduates.

As far as data breach, on October 5th, 2023, BOE became aware that a hacking group known as RansomVC claimed to have breached BOE's records and accessed 600 lines

U.S. voter data, including D.C. voter While BOE is still investigating this records. matter, we know that voter records were accessed through a breach of the web server of DataNet Systems, BOE's website host. No internal BOE databases, networks, or servers were directly compromised.

BOE has taken the following actions during the initial phase of our investigation.

BOE initiated an internal assessment and began working with its data security and federal government partners to investigate the breach.

These partners include, but are not limited to, the Multi-State Information Sharing and Analysis Center, or MS-ISAC, the Federal Bureau of Investigation, and Homeland Security.

BOE collaborated with MS-ISAC's computer incident response team to resolve the issue. BOE has also received support and guidance from the Office of Chief Technology Officer. BOE directed DataNet to take down our website and replace it with a maintenance page

upon learning that our website was the source of the breach. A static website is now up, and we are continuing to populate it with additional content.

BOE conducted weekly vulnerability scans on our database, server, and other IT networks. We have set up an email account where residents can ask questions, and that is questions@dcboe.org.

During the investigation, it remains safe and secure to register to vote in the District of Columbia. D.C. residents can still register to vote online, by using a paper form, or in person at BOE offices. It should also be noted that in the District of Columbia some voter registration data, such as voter names, addresses, photo records, and party affiliation, all public information, unless it has been made confidential in accordance with District of Columbia rules and regulations. BOE shares this information upon request and in compliance with the law.

At this point, we know that DataNet Systems' breached database server did contain a copy of D.C. BOE's voter roll. Therefore, out of an abundance of caution, BOE is working with DataNet Systems to contact all registered voters.

MS-ISAC completed their has engagement and issued а report stating the vulnerabilities with DataNet's practices. Specifically, DataNet Systems failed to deploy security updates and patches and failed conduct routine vulnerability scans.

Next steps. BOE will engage in a system penetration testing at least annually. BOE is exploring options for а permanent website hosting solution, and these current options do include conversations with working with BOE is DataNet to ensure comprehensive response to the breach, including notifying all registered D.C. voters that that plan is in place.

on Executive Administration and Labor of the Council District of of the Columbia held roundtable on t.he BOE data breach in preparation for the 2024 election cycle. provided information regarding the data breach, the investigation, and next steps.

BOE also updated information that was given during the June 2023 roundtable on 2024 election planning. BOE is preparing a response to the Council that provides additional information. The official record closes on November 10, 2023, at 5:00 p.m.

Precinct mapping. As required is regulations, the Board looking at current precinct boundaries to divide District into appropriate voting precincts based on our election wards. A file has been sent to OCTO to verify the SMDs and precinct alignment, and the precinct mapping plan has been sent to Councilmember Bonds for review.

ANC vacancies. We have 14 ANC vacancies for the 2023-2025 term. These

positions are in different stages of being filled. After candidate filing requirements are met, an open vote of registered voters of the affected SMD will be held during regularly scheduled ANC meetings.

have been working with We the Department of Corrections to fill the vacancy at the ANC that the represents the jail, and petition and challenge that is 7F-08. The processes have ended. The ANC will be conducting the special election in December.

List maintenance. Our 2023 list maintenance process is still actively underway.

A non-forwardable postcard was sent to every voter who did not vote in the November 2022 general election. Based on that data, we mailed a second postcard that was forwardable to those individuals. The forwardable postcard was also mailed to voters who had a ballot returned as undeliverable in 2022.

To date, we have removed 65,544 voters from our voter rolls. An additional

37,962 inactive voters will be removed from our voter rolls before December 31st. We have moved another 73,522 to an inactive status.

We are in the process of sending a second batch of forwardable mailers. Once that second batch is sent, an additional 20,000 voters will be moved to an inactive status.

Next steps and off-year election planning. draft Our primary and general election calendars for 2024 are posted on our website. We are implementing the requirements Elections Modernization Amendment of the Act and the Local Resident Voting Rights Amendment We have met with VR Systems, our voter registration database vendor, to provide database solution to house non-citizens who registered to vote in local elections.

Our current timeline to implement the database to register non-citizens for local elections includes delivery of initial software updates to BOE, BOE review of software updates, and we will provide feedback, revision of

software date -- revision of the software based on our feedback, and then of course training BOE staff.

We preparing to register are non-citizen residents to vote in January 2024. We will acquire additional equipment to assist with our mail ballot processing activities. receive funding in our FY2024 budget purchase an additional Agilis machine to sort the ballots and signature verification software. We are also acquiring DS950 equipment that will be used to tabulate ballots.

The Agilis and DS950 equipment purchases are currently with the Office of Contracting and Procurement.

The comment period for our proposed vote center and mail ballot dropbox locations closed on October 2nd. We are in the process of reviewing comments received. BOE plans to have 55 mail ballot dropboxes that will be placed throughout the city. We also plan to

operate 25 early vote centers and a total of 75 election day vote centers.

Accessibility. We are conducting an accessibility survey of all prospective vote centers before the 2024 election cycle, regardless of whether they have been used previously or not, to ensure the vote centers remain accessible.

partnering with disability are rights at University Legal Services and the Office of Disability Rights to conduct surveys. As is our practice, we will also partner with DGS that both to ensure centers are structurally accessible. We will also ensure election workers that are aware of the Americans with Disabilities Act guidelines, as well as the operational accessibility concerns have been raised, and that that they promptly and effectively address to these issues as they arise.

The Election Worker Training

Division is revising the election worker

handbook and the training curriculum based on recently passed legislation. The recruitment of quality election workers is important, and their presence at vote centers requires attention to detail.

During the 2024 election cycle, our goal is to recruit and train between 2,000 and 2,500 election workers. We will deploy approximately 1,700 election workers to serve at both centers. Election worker training will begin on Tuesday, March 2nd, 2024.

We will provide training classes for registration clerks, ballot clerks, voter assistance clerks, site coordinators, and area reps. Classes will be offered six to seven days a week for 10 weeks. Election workers are also able to access online training -- the online training module to complement the required in-person classes.

Voter education and outreach.

During the month of October, the Voter

Education and Outreach Division conducted 19

outreach events on behalf of the agency.

Events included the 2023 Disability Tech Summit

at the Convention Center and a naturalization

ceremony held at the United States District

Court on October 10th.

registration rolls. Voter In October, we registered 2,071 new voters processed 17,008 registration changes. In total, we prepared 19,079 voter registration cards to be mailed. Additionally, 2,697 registered voters moved out of D.C., 492 voters canceled their registration and registered with jurisdictions, 1,045 other and voters registered in D.C. after canceling registrations in other states.

We are continuing to register voters using our website portal. To date, we have processed over 39,294 applications using the portal. These include new voter registrations and updates to existing registrations.

CHAIR THOMPSON: All right. Thank you very much. It's great to hear about new voters registering to vote. Critical thing.

And I was just reflecting on the fact that a year ago, here we were in the wake of the general election talking about our list maintenance and how many potential names were on that list that were no longer active or had moved out of D.C., et cetera. There was quite a lot of talk about that, and we promised to drill down on the details and spend careful time following our processes, to meticulously improve the list.

And, you know, it's just great to hear that after a lot of hard work, here we are talking about improving the list with voters who no longer live here or who are no longer active having been confirmed through that meticulous process being moved to inactive status or off the rolls completely, and it really — it will have a significant impact on what I always call the denominator when a voter

initiative or a candidate has to obtain a certain percentage or a certain number of signatures driven by percentages.

So it's really important work. It's detailed work. It's one of the major things that happens in between election cycles, and it's really great to hear we are nearly concluded that very laborious process. So thank you for that.

That was just a comment. And with that, General Counsel's report from Terri Stroud.

MS. STROUD: Good morning, everyone.

Before I get into the substance of my report, I

just wanted to introduce two new staff

attorneys who began with the Office of the

General Counsel on October 23rd. We have Jorge

Quintana and LaKetha Walker.

Jorge comes to us from the District

Court of Maryland where he served as a

commissioner. He practiced law in Montana for

about 20 years, including serving as chief

legal counsel in the Montana Secretary of State's office for about seven years where he had exposure to election law and administration.

Walker LaKetha comes t.o นร Louisiana where she practiced for law about most recently administrative 12 years, as an law iudae in the state's Division of Administrative Law. She has also served as an attorney with the Louisiana Department Health and as assistant DA in several counties.

So welcome, Jorge and LaKetha.

We are very happy to have you here, and we all look forward to working with you.

So for litigation status, we have four matters. The first is Public Interest

Legal Foundation versus Monica Evans in her official capacity as the Executive Director for the Board. This matter is in the U.S. District Court for the District of Columbia.

It was filed under the National Voter Registration Act, and it alleges that the

is out of compliance with the public records provision because the Board denied a request for particular records related electronic registration information the center, and we denied that request based on the records being subjected not to public disclosure.

All of the pleadings in this matter have been filed, and a hearing has been scheduled on the pending motion to dismiss for December 4th.

The next matter is Stacia Hall versus the Board. This is also in the U.S. District Court for the District of Columbia. This is a challenge to the Local Resident Voting Rights Act. As this is a challenge to the constitutionality of an act of the Council, the Board is being represented by the Office of the Attorney General.

All pleadings have been filed in this matter, and we are awaiting the Court's ruling.

The next matter is District of Columbia Democratic Party versus Muriel Bowser, et al. The Board and the District government are also named defendants. This case was in the D.C. Superior Court. It was a challenge to initiative measure number 83.

And prior to the initial hearing, which was set for November 6, the plaintiffs withdrew the complaint. And that is because an additional complaint was filed in the same matter, and the caption is the same, with the addition of an additional plaintiff.

On October 3rd, the defendants filed a joint motion to dismiss, and we notified the court that the statute requires that the case be expedited. The plaintiffs filed their opposition on November 4th, and the defendant's reply is due on November 13th. An initial hearing has been set for December 1st.

And that concludes the litigation status and my report.

Turning now to campaign finance, Cecily Collier-Montgomery.

MS. COLLIER-MONTGOMERY: There were no new certifications or disbursements from the Fair Elections Fund which were authorized by the agency during the month of October 2023. In terms of desk reviews, the office -- the Elections Division conducted 19 desk Fair reviews of reports of receipts and expenditures, and also issued 11 requests for additional information concerning the review of the amended reports of receipts and expenditures.

The Fair Elections Division also conducted four candidate treasurer consultations during the month of October, first for Markus for One Ward 8, Committee to Re-elect Janeese Lewis-George, Veda for Ward 7 2024, and for Rodney "Red" Grant for City Council.

As of October 31, 2023, with respect

to remitted funds from the Fair Elections
Program, the total sum of \$803,207.20 has been
remitted for deposit in the fund from the
campaign operation of the candidates who were
certified to participate during the 2022
election cycle.

With the ongoing 2020 post-election full field audits, again, the OCF initiated 34 full field audits of the campaign operation of the candidates who were certified to participate in the Fair Elections Program during the 2020 election cycle.

There are currently 11 of these post-election audits which are ongoing before the division at various stages of the audit process. And, again, with respect to the status of those audits, that is detailed in our report, which again will be filed or posted on our website this afternoon.

FEP Division has issued a total of
23 final audit reports of the post-election
audits which were initiated for the 2020

election cycle, and those audits are available for review by the public at our website.

With the ongoing 2022 post-election full field audits, the Office of Campaign Finance issued approximately 42 post-election audit. letters for the candidates who participated in the June 2022 primary election and the November 2022 general election. 19 has issued preliminary date, the FEP statements of audit findings and 12 final audit reports for the 2020 election cycle, including for the month of October the following: Nina O'Neill for D.C., the final audit report was issued on October 12th, 2023, which compliance audit report.

Together with Wiley, the final audit report was issued on October 12th, 2023, which was also a compliance audit report. Elect Ms. Carisa Stanley Beatty for D.C. Board of -- State Board of Education, Ward 5, preliminary audit findings were issued on October 13th, 2023. And for Elect Mr. Ben Michael Williams

The first was the October 2nd, 2023 due date for the filing of the financial reports by the constituent service programs at our senator or representative statehood fund program.

And the October 10th, 2023 due date for the filing of the financial reports for our Political Action Committee, the Independent Expenditure Committee, and the Fair Elections Program Candidate Committees. The real-time images of the reports are available at our website for review by the public.

For the 2023 election cycle, with respect to new candidates and committees, and

In our Fair Elections Program, again, there are currently nine candidates who are registered to participate in the program, including four new registrations for the month of October.

And those registrations are Kevin Rapp, candidate for At-Large Member of the Council, the June 4th, 2024, primary election.

The candidate registered on October 1st, 2023.

Janeese Lewis-George, candidate for Member of the Council from Ward 4, the June 4th, 2024, primary election. The candidate registered on October 4th, 2023.

Markus Batchelor, candidate for Member of the Council from Ward 8, in the June 4th, 2024, primary election. The candidate

Also, in the traditional program, four candidates and treasurers completed the OCF entrance conference, and those candidates were Kevin Rapp, candidate Council At-Large; Janet McHale (phonetic), treasurer, Committee to Re-elect Janeese Lewis-George; Kevin Rapp, Treasurer, Kevin Rapp for Council At-Large; and Jonathan D. Hill, Treasurer, Markus for One Ward 8.

The Public Information and Records Management Division, during the month of October, also referred four Political Action Committees for the failure to follow the 10th receipts October report of and expenditures to the Office of the General Counsel for the initiation of the enforcement process.

The names of those committees are listed in our report, again, which will be posted on -- today.

For the report's Analysis and Audit that is our traditional campaign Division, finance audit program. The Audit Branch conducted 64 reviews of reports of receipts and expenditures that have been filed, and also for additional issued eight requests information letters concerning the review of those reports.

The traditional Audit Branch issued two final audit reports during the month of October. The first was the D.C. Latino Caucus PAC, and the audit report was issued October 31st, '23, and that was a compliance audit report. And the audit was a periodic random audit which was conducted on the July 2023, receipts 31st, report of and expenditures, which had been filed by Political Action Committee.

The second was D.C. Young Democrats,

and that final audit report was issued on October 31st, '23, and was a compliance audit report. And, again, the report was of the July 31st report of receipts and expenditures, which had been filed by the committee.

There are currently three ongoing full field audits before the traditional Audit
Branch. The first is a full field audit of a newly elected official, and that is of the Kenyan McDuffie 2022 Principal Campaign
Committee, and that is ongoing.

The second is a random periodic audit, which is being performed of a Political Action Committee as July 31st, 2023, report of receipts and expenditures. The Political Action Committee is the Citizens for Empower (phonetic), and basically I would also note for the record that the bank account of the committee was closed.

And we have received a letter from the bank which confirms that the third full field audit is of the D.C. Proud Inaugural

Committee, and that particular field audit is ongoing.

And that concludes my report, but I

would ask Mr. SanFord to provide the report of the Office of the General Counsel for the Office of Campaign Finance.

CHAIR THOMPSON: Good morning,
Mr. SanFord.

MR. SANFORD: Good morning, Mr. Chairman, and good morning, distinguished Board Member Boggs.

I'd first like to start by introducing the newest members of the Office of the General Counsel for the Office of Campaign Narita Finance, and they Gonzalez are (phonetic) and Tina Ball (phonetic). They both bring a wealth of experience to the agency.

They both commenced their journey with the Office of Campaign Finance in September, and we are looking forward to having them on board. And we have high expectations of their contributions they will make during

CHAIR THOMPSON: Welcome. Welcome to everybody starting.

MR. SANFORD: Thank you very much.

Regarding the reporting, during the month of October, the Office of the General Counsel received four referrals from the Public Information and Records Management Division, completed 21 informal hearings, and issued one order, including -- which included -- issued 10 orders, which included the following: two orders to vacate were issued, two orders to vacate notices of hearings or prior orders, three orders in which a total of \$950 in fines was imposed, and five orders were issued in which no fines were imposed.

During the month of October 2023, the Office of the General Counsel imposed fines against the following respondents. A fine of \$50 was imposed against Thaddeus James, former Advisory Neighborhood Commissioner candidate.

A fine of \$850 was imposed against

Friends of Best, a Principal Campaign Committee in the 2022 election cycle.

And a fine of \$50 was imposed against Robin McKinney, a former Advisory Neighborhood Commission candidate.

During the month of October 2023, the Office of the General Counsel collected \$100 in fines from McKinney, former Advisory
Neighborhood Commission candidate. That has changed, former Neighborhood Commission candidate.

And also collected a \$500 payment towards a repayment that former candidate and current Council Member Zachary Parker is required to repay the Fair Elections Program.

During the month of October 2023, the Office of General Counsel transmitted eight for enforcement to the Office petitions General Counsel the Board of Elections. for petitions for the following The were Ward 2 respondents: James State Board of Education, Evan Redd PAC (phonetic), Markus for

During the month of October, 2024 (sic), there for were no requests interpretative opinions, and no show proceedings were conducted.

I do know that there are still some more work to be done. I used 1900 F Street as example throughout this process, because it's а freshman dorm at George Washington University. And when I was looking over the voter roll, I still noticed that there are still people that are registered to vote there in 1998. So there's -- I know there's still some more work to be done.

Number two, I'm going to post in the chat real fast a link. I know the website is under maintenance, and I just have a quick follow-up on that is that this link here is a check your voter registration status.

When we start the signature collection effort, one way that petition

circulators are able to engage voters in a way to ensure that they have a valid -- collect a valid signature from a registered voter is being able to use that link. I create QR codes that we put on the clipboards, so if a voter is not sure where they're registered to vote, they can just, you know, whip out their phone and be able to check to see if they're -- where they're registered to vote.

now, because Right the website is under maintenance, that page is not available. And it would be really -- it's very important that that interactivity is added or possibly an app is created by the Board so that a voter who is out in the field can be able to check their registration immediately. if voter Because someone writes down the wrong address, know, that signature might not count. And that tool that the Board of Elections had available was very useful for political campaigns.

And then the last mention is that the press release that was issued I believe on

October 6th about the hack, it said that the Board was made aware on October 5th. I brought the attention to the Board on October 4th that there was malicious code that had been added to the Board of Elections website. CHAIR THOMPSON: Can I just ask real quick, he mentioned an address of a GW dorm.

Is that something we can look at?

MS. EVANS: Yes. And of course the universities, that is always our biggest challenge, just making sure we have accurate information, but we are looking into that. So we're working with all of the universities, because some universities have one address that actually signals different SMDs, if you will.

So there are a number of issues we're working with universities to correct in short order.

In reference to the hack, the date that we reported was the date that we had some indication that the voter roll was hacked. Of

course, there was potentially some other activity, including the activity that you reported earlier that week. And so it is likely part of the same group, but based on the information we have from MS-ISAC, there could be multiple players involved.

And so since we are referencing what we know today from the RansomVC group, that is the information that was in the October 6th press release that we put out.

I hope that provided clarification to your questions.

CHAIR THOMPSON: And he also asked about fixing the check your registration status.

MS. EVANS: Oh, yes. And that is also something -- thank you, Chair -- that will be corrected. We have been working on updating and getting a new temporary website launched, and we hope to have that pretty much underway by next week.

We're working on some minor issues

1 and some irregularities that we have identified 2 as we have gone through the full site. But our 3 target is next week, and then voters will be 4 able to check their registration from that as 5 well. MR. AMENE: Yeah. I made that -- I made that comment using the same form after the breach, so I believe it seems to be still operational.

I am just going to reiterate what I said in my comments and just go through them a little bit. I'm just going to drop for people who are paying attention some links in the --

from what I'm going to be talking about.

In particular, I want to talk about page 15 of the rulemaking, and this is the most important part when it comes to Local Resident Voting Rights Act. The way you have it written here, it's -- I'm looking at 500.2, subsection B. What I am concerned about is the use of the term "ballot measures."

MS. STROUD: The word should have been "ballot question," "question" as opposed to "ballot measure." Because a ballot question encompasses charter amendments, which is what you pointed out. So that is something that with final will be corrected, not the rulemaking that we're going to put forth because I don't want to delay the entirety of the rulemaking from going forward, since that could be considered a substantive change.

And so what we're going to do is submit that as part of another proposed rulemaking, so that should have said "ballot question" as opposed to "ballot measure."

MR. AMENE: That is great. And, thankfully, we don't have any charter amendments coming up, so that shouldn't be an issue. I appreciate you taking my comments.

MS. STROUD: Yeah.

MR. AMENE: Thank you.

MS. STROUD: That regulation would have been in conflict with the statute. That wouldn't have been an issue because we -- you know, it wouldn't have -- that statute would have trumped the regulation that would've been in error. So there wouldn't have been an issue in terms of ensuring that local residents could vote on a charter amendment were one to have come down the pike.

MR. AMENE: I appreciate it very much. Thank you very much.

Just to follow up, as far as the -is there any update on the registration
process, I guess this would be more a question
for the Director, any clear timeline besides
definitely before January 1st? I know that you

have a little bit more detail. I would love it.

MS. EVANS: Yes. And in my report I did just briefly list the number of steps that will take us to the deployment of that portal.

And we expect to complete staff training with that additional database in mid-December. And so no later than the beginning of January we are anticipating going live with that.

So some of it just depends on the revisions that are presented to BOE and walking through and testing those revisions and just determining how many there are. So it's a somewhat fluid timeline, but definitely mid-December with a deployment date early January. However, we said at least by early in the event January. So we get revisions, then it is possible that we can move forward with that, even in December.

MR. AMENE: Now, to ask this of the Board I guess and their interpretation of these rules, I am considering running for office, and

technically right now I am not a registered voter. How will you be interpreting the requirement that I need to be a registered voter? Even though I'm eligible, I'm just physically not able to because the process is not ready.

I will, by the time I take office, if I do take office, be a registered voter.

How will you be interpreting that requirement that, you know, an elected official when they take office has to be a registered voter. But right now -- the vacancy is open now, and the vacancy petition collection would be now.

So how will you deal with this discrepancy and the fact that I cannot physically say that I am a registered voter until this process is ready, but that is a prerequisite of running for office that is currently open that I am technically, you know, legally eligible for but physically not able to because the registration process is not ready.

I would love any input on that and

1 any advice on that. would defer to 2 MS. EVANS: Т mУ 3 General Counsel, but prior to candidate pickup, 4 the registration process for non-citizens will 5 be active. And so before that date, there will be no issues with stating you are a registered 6 7 voter. 8 MR. AMENE: Just to clarify, this 9 would be a vacancy and the process would be --10 I believe the petition collection process has 11 started as of yesterday. You said they could -12 13 So if you -- we can talk MS. EVANS: 14 to you offline about that, just to ensure that 15 you have the proper information going forward. 16 MR. AMENE: I appreciate it. Are those 21 all your questions? If you could --22 MS. BRIZILL: No. I'd like to go --

CHAIR THOMPSON: If you could --

MS. BRIZILL: -- one by one.

CHAIR THOMPSON: Yeah. Just please let us know your points, and then we'll address them, kind of in the way Mr. Schiller did. If you could finish your comment, please.

MS. BRIZILL: The second thing is is that I'd like to get some clarification on what the role of your Communications Director is.

As you know, she is new to the staff. I had not met her. I approached her before the start of the meeting and indicated I would like to introduce myself and to speak with her after the meeting.

She told me she'd have to consider it. What does that mean? I had thought that with the hiring of a new Communications the 2024 Director, especially prior to election, we would improve -- I stress improve -- communications between this Board and the public. Have you directed Communications Director not in fact to speak to members of the

My last points concern planning for the 2024 election. Can I get an update as regards to what the real status is currently at the warehouse? Are there working toilets? Is there running water? What are the plans for using the warehouse for the storage of equipment and the tabulation of votes in 2024?

Moreover, can Ms. Evans give a more detailed rendition as regards what equipment is still to be purchased, what equipment needs to repaired, and what the future of backup equipment for the 2024 election is, because we have situations where, at least in Ward 1, machines went down, especially printers, they were not repaired or replaced for several hours.

Thank you very much.

CHAIR THOMPSON: Okay. Thanks for your comments. I will just briefly address the issue of our meetings. It's, obviously,

entirely within our discretion whether to have meetings be physically open to the public here in our Board Room or just by Zoom. We have shifted back and forth. Mostly recently, we shifted back to a remote or Zoom-only format, not just due to pandemic concerns but to some extent safety concerns that I don't want to go into.

But it felt like the right call to proceed remotely, at least for a while, until we feel like it would be safe to have the meetings open to the public. That's something we'll think about for future meetings, especially as we head into special issues that might be raised.

I'm sure they will be raised in the next election cycle, so thank you for your comment. It's something we will continue to take under advisement.

The other matters you raised are within the province of the Executive Director and her staff, so I would defer to Ms. Evans.

MS. EVANS: Yes. And good morning,

Ms. Brizill. The first question you asked was
about clarification of the role of the Director
of Communications. And, no, the Director of
Communications has not been directed to have no
comment or interaction with members of the
public.

I don't know what she said to you, so I can't really comment about what she said or didn't say to you, but I don't know what her schedule is after the meeting. So I don't know if that had to do with her schedule or what she has planned for the day.

So because I wasn't a part of that, it's difficult for me to address the specifics of that engagement. But, no, there was no directive for our Director of Communications to withhold meetings with members of the public or you in particular.

MS. BRIZILL: Can I respond to that before we go on?

CHAIR THOMPSON: Hold on. Let her

finish. I think you wanted to --

MS. BRIZILL: Something to finish?

CHAIR THOMPSON: Yeah. Just maybe address the warehouse question, and we'll permit one brief follow up.

MS. EVANS: As far as planning for the 2024 election and status of the warehouse, we did receive a quote from the landlord about modifications to the current warehouse space. DGS is now looking at costing that out, and so the two options that are currently available is just a temporary move for 2024 or looking to see if we have enough time for a permanent move, and then continue renovations with portions of the space as we occupy areas that are currently able to
