DCBOE Has Completed the Recount in three ANC Races

WASHINGTON, D.C., On November 30, 2018, the District of Columbia Board of Elections (DCBOE) began a recount of the votes cast in three Advisory Neighborhood Commissioner (ANC) races that were on the ballot in the November 6, 2018 General Election. The recount took place on November 30, 2018.

DCBOE recounted all ballots cast in precincts 19, 45, 49, 116, 117 and 120. The recount of the listed precincts resulted in a change in outcome from the certified election results with respect to Single Member Districts (SMDs) 4C08 and 8E01. The result of the recount with respect to SMD 5E05 produced no change in outcome. Accordingly, DCBOE will certify the results, based on the recount referenced below, at the regular Board meeting scheduled for December 14, 2018 at 1:30 pm.
