DCBOE Publishes Results of the Manual Audit

WASHINGTON, D.C. – The District of Columbia Board of Elections (DCBOE) has completed the public manual audit of the November 6, 2018 General Election, which took place on Tuesday, November 13 and Wednesday, November 14, 2018.

As required by District law, the DCBOE conducted a hand count of all votes cast in one randomly selected precinct per ward in one (1) citywide contest (Attorney General) and two (2) ward-wide contests for the audit (Ward 1 Member of the Council and Ward 6 Member of the State Board of Education). The Executive Director selected an additional contest, the Ward 6 Member of the Council contest, for audit as well.

Typically, differences between the hand count and the machine count are the result of additional or incomplete marks made by a voter on the ballot or the result of counting errors made by members of the audit team.

The margins of error do not exceed the statutory allowance of 0.25%, and therefore, no further action is required by the Board. Official results of the November 6, 2018 General Election will be certified during the Board's regular public meeting on November 15, 2018 at 10:30 am.

The District of Columbia Board of Elections is an independent agency of the District of Columbia Government responsible for the administration of elections, ballot access, and voter registration.
