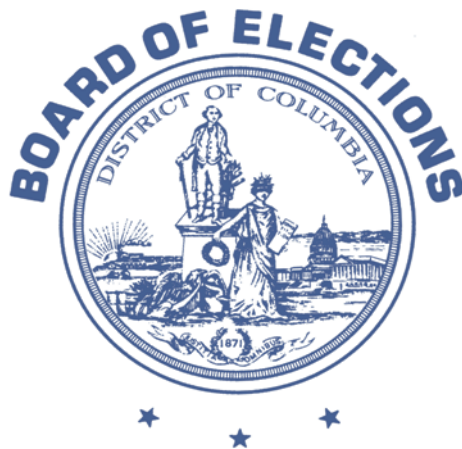

Communication Assistance-DC Relay

District of Columbia Relay (DC Relay) provides traditional relay services for the District of Columbia, including teletypewriters (TTY), Voice Carry Over (VCO), Hearing Carry Over (HCO), Speech-to-Speech (STS), Spanish-to-Spanish, and CapTel®.

When you connect with DC Relay, a Communication Assistant (CA) will facilitate the call. Simply give the CA the number you wish to call, and your call will be processed promptly, professionally, and accurately.

Letter from the Board of Elections

Dear Voter:

The District of Columbia Board of Elections is pleased to provide you with this Voter Guide for the June 2, 2020 Primary Election (the Guide). We hope the Guide will be a valuable resource as you participate in the election process.

Please note, the Board of Elections has modified its operations in order to mitigate the spread of the coronavirus (COVID-19). We are committed to providing a safe environment where every vote is counted. Voting by mail is strongly encouraged to protect the public, staff and election workers. **Two Absentee (Mail-in) Ballot Request Forms to receive an absentee (mail-in) ballot are included in this Guide along with a postage-paid envelope.** Visit our website to find other ways to request an absentee (mail-in ballot) application and to learn more about changes to the upcoming 2020 June Primary Election at <https://www.dcboe.org>.

The Guide provides answers to questions frequently asked by voters, such as:

- can I vote in this election? (see **page 4**);
- how do I register to vote? (see **page 5**);
- what are my choices for casting a ballot? (see **pages 6 through 7**);
- what if I need help with voting? (see **pages 10 through 11**); and
- what contests and candidates are on the ballot? (see **pages 14 through 50**).

The Guide also contains information on key dates to remember (see **page 2**), voter rights and responsibilities (see **page 12**), and prohibited election practices (see **page 13**).

Here are some additional things you should know:

- Beginning May 22 through June 2, 2020 (Election Day) 20 Vote Centers will be open to allow voters to same day register to vote, update voter registration, vote in-person, and submit ballots received by mail.
- Same-day registrants who provide acceptable proof of residence in the District of Columbia will be able to cast a regular ballot. (See **page 5** for acceptable forms of proof of residence.)
- Registered voters may file changes of address at any of our Vote Centers. To vote a regular ballot, voters must provide proof of their new address. (See **page 5** for acceptable forms of proof of residence.)
- The Board will operate 20 Vote Centers to accommodate voters (See **page 8** for locations).
- In light of the state of emergency and public health issues associated with COVID-19, if you choose to vote in person, voters visiting Vote Centers are encouraged to vote on a staggered schedule based upon last name. (See **page 9** for the recommended in-person voting schedule.)

We encourage all District of Columbia residents who are eligible to vote in the Primary Election to do so. The Board encourages each voter to request their absentee (mail-in) ballot as soon as possible, and to return it to the Board quickly once received. **If you have not already done so, please use the Absentee (Mail-in) Ballot Request Form provided in this guide along with the postage prepaid envelope to request your ballot.** The Board is prepared to accommodate every voter who makes such a request. We are working hard to ensure that your voting experience is a positive one. If you have any questions or concerns, please do not hesitate to contact us.

Key Dates to Remember

TUESDAY, MAY 12, 2020

- Deadline for the receipt of voter registration applications submitted by mail, online at www.vote4dc.com, and through the Board's mobile app, Vote4DC.
- Deadline for registered voters to change their party affiliation status.

Friday, May 22, 2020 through Monday June 1, 2020 (INCLUDING WEEKENDS)

8:30 am-7:00 pm (closed on May 25th for the Memorial Day Holiday)

Tuesday, June 2, 2020 (Election Day) 7:00 am – 8:00 pm

- Absentee (Mail-In) Ballot drop-off, in-person voting, and same-day registration are available at all 20 Vote Centers. (See **page 8** for locations.)

TUESDAY, May 26, 2020

- Last day the Board will accept **regular** absentee (mail-in) ballot requests. Requests must be received by 4:45 pm.

SATURDAY, May 30, 2020

- Last day the Board will accept **military and overseas voter** absentee (mail-in) ballot requests. Requests must be received by 4:45 pm.

TUESDAY, JUNE 2, 2020: PRIMARY ELECTION DAY – LAST DAY TO VOTE!!!!!!

(7:00 am-8:00 pm)

- As long as you are in line by 8:00 pm, you will be able to vote.
- All absentee (mail-in) ballots must be postmarked by June 2 and received at the Board by June 9, 2020 in order to be counted.

Election Technology

Voting Machines

The District of Columbia uses the ES&S EVS 5.3.1.0 voting system. This system features the DS200 Precinct Scanner and Tabulator, an optical scan machine that tabulates ballots marked either by hand or by the accessible ExpressVote ballot marking device. The ballot marking device allows voters with disabilities to vote privately and independently. The DS200 allows the Board to securely transmit election results from the polling places to the Board when voting has closed on Election Day.



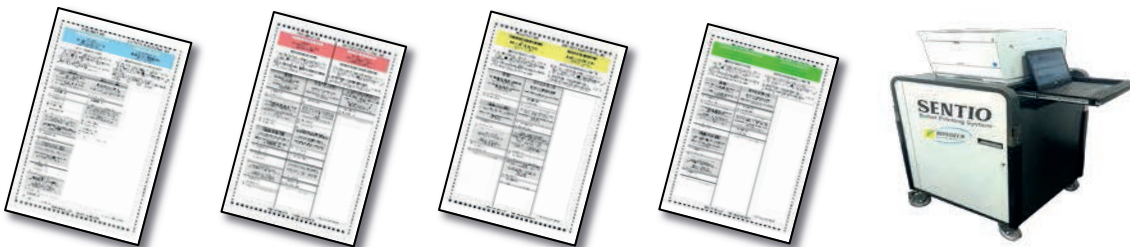
Electronic Pollbooks

Election workers check voters in using the KNOWiNK Poll Pad. Election workers can scan Department of Motor Vehicles (DMV)-issued identification (ID) cards and voter registration cards to access voter information instantly, or they can use the manual search option to identify voters.



Ballot on Demand

Ballot on Demand printers can produce a voter's exact ballot when they arrive at a Vote Center.



Can I Vote in this Election?

You can vote a party ballot in the June 2, 2020 Primary Election if:

- you are a United States citizen,
- you are a resident of the District of Columbia,
- you do not claim voting residence or the right to vote in another U.S. State or territory,
- you are at least 17 years old and you will be at least 18 years old by the November 3, 2020 General Election,
- you are not in jail for conviction of a crime that is a felony in the District of Columbia,
- you have not been found by a court to be legally incompetent to vote,
- you have resided in the District of Columbia for at least 30 days immediately prior to the election, and
- you are registered with one of the four parties that are eligible to conduct a primary election (Democratic, Republican, D.C. Statehood Green, and Libertarian). *

** Registered voters must be registered with one of these parties as of Tuesday, May 12, 2020, the last day to change party affiliation status; same-day registrants may register with one of these parties when they vote.*

How Do I Register to Vote?



You can register online at www.vote4dc.com, through the Board's mobile application, Vote4DC, or by mail using a form you can download at <https://www.dcboe.org/voterregistrationform>.

The deadline for the receipt of all voter registration applications submitted in these ways is **Tuesday, May 12, 2020**, the 21st day before Election Day. However, the District of Columbia offers **same-day registration**. You can register at the Vote Centers during In-Person Voting (Friday, May 22, 2020 through Tuesday, June 2, 2020 -- Election Day).

To register at a Vote Center, you must provide proof of residence that shows your name and current District of Columbia address. Acceptable forms of proof of residence include:

- current and valid District of Columbia DMV-issued ID,
- utility bill for water, gas, electricity, cable, internet, telephone, or cellular phone service, *
- savings, checking, credit, or money market account from a bank or credit union, *
- paycheck, stub, or earning statement that includes the employer's name, address, and telephone number, *
- government-issued document or check from a federal or District government agency, *
- current residential lease or rental agreement,
- occupancy statement from a District homeless shelter, * and
- tuition or housing bill from a District of Columbia college or university issued for the current academic or housing term.

* Must be dated no earlier than **March 4, 2020**.

If you are a first-time voter in the District of Columbia who registered by mail and you did not provide proof of identification at the time of registration, you may be required to provide identification when you arrive to vote. Acceptable forms of identification include the forms listed above.

If you wish to **update your address** at a Vote Center, you must provide proof of residence that shows your name and current District of Columbia address. Acceptable forms of proof of residence include those listed above.

What Are My Choices for Casting a Ballot?

As a registered voter in the District of Columbia, you may vote in one of two ways: absentee (mail-in) or in-person at a Vote Center. Please note, the Board of Elections has modified its operations in order to mitigate the spread of the coronavirus (COVID-19). We are committed to providing a safe environment where every vote is counted. Voting by mail is strongly encouraged to protect the public and election workers.



1) VOTE ABSENTEE BY MAIL

If you have not already done so, please use one of the Absentee (Mail-in) Ballot Request Forms provided in this guide along with the postage prepaid envelope to request your ballot.

Visit www.vote4dc.com, or use our mobile app, Vote4DC, to submit an electronic request for an absentee (mail-in) ballot. You may also use one of the two Absentee Ballot Request forms found in this Guide, or download and print a copy of the form at <https://www.dcboe.org/AbsenteeBallotRequest>. A Ballot Request form may also be requested by emailing DCabsentee@dcboe.org. In addition, the Board will accept any written request for an absentee ballot that includes your name, residence address, mailing address (if applicable), date of birth, the election(s) for which the ballot is requested, your original signature, and either your DMV-issued ID number, the last four digits of your Social Security Number, or your voter ID number. You may also request an Absentee Ballot Request form by calling the Board at 202-741-5283 (711 TTY) or by downloading and faxing an Absentee Ballot Request form to 202-347-2648. **The Board must receive your request for an absentee ballot by no later than 4:45 pm on Tuesday, May 26, 2020.**

Military and Overseas Voters

Additional services are available to military and overseas voters (members of the uniformed services, their spouses or dependents, and overseas civilian voters). U.S. citizens who were born overseas have the opportunity to vote from the same address where a parent most recently lived in the District of Columbia.

Military and overseas voters can use the Federal Post Card Application (FPCA), which serves as a combined voter registration and absentee ballot request document. The FPCA is available for download from the Department of Defense's Federal Voting Assistance Program (FVAP) at <https://www.fvap.gov/district-of-columbia>. You may email your completed FPCA to uocava@dcboe.org. **The Board must receive your request for a military/overseas absentee ballot no later than 4:45 pm on Saturday, May, 30, 2020.**

You can receive and return your absentee ballot by mail, fax, or email. If it is getting close to Election Day and you have not received your absentee ballot, you can use the Federal Write-In Absentee Ballot (FWAB) as an emergency, backup ballot. FVAP provides fillable FWABs and provides assistance in using FWABs at <https://www.fvap.gov/district-of-columbia>.

What Are My Choices For Casting a Ballot?

Eligible Incarcerated Voters

Eligible individuals at the Central Detention Facility (DC Jail) and the Correctional Treatment Facility (CTF) who are incarcerated for non-felony convictions and individuals who are awaiting trial may vote in the June 2 Primary. These individuals must request an absentee (mail-in) ballot from the Board. **ALL VOTED ABSENTEE BALLOTS MUST ARRIVE AT THE BOARD BY TUESDAY, JUNE 9, 2020.**

Residents of Licensed Nursing and Assisted-Living Facilities

Eligible residents who are living—temporarily or permanently—at licensed District of Columbia nursing homes, assisted-living facilities, or federal medical centers may vote in the June 2 Primary. These residents may vote at a Vote Center or request an absentee (mail-in) ballot. **ALL VOTED ABSENTEE BALLOTS MUST ARRIVE AT THE BOARD BY TUESDAY, JUNE 9, 2020.**



2) VOTE IN PERSON AT A VOTE CENTER

You can cast your ballot at any Vote Center, regardless of your residential address. Each voter will be checked in with Poll Pads that are connected over a secure network so that a voter cannot check in and cast a ballot at more than one location. Absentee (mail-in) ballots may also be deposited at any of the Vote Centers.

Note: It is a crime to attempt to vote twice in any election within the District of Columbia. If you want to monitor the voting process, call the Board's office and ask to serve as an election observer.

Vote Centers will be open every day during the timeframe indicated (including the weekends, but excluding Memorial Day) from 8:30 am to 7:00 pm. On Election Day (June 2), Vote Centers will be open from 7:00 am to 8:00 pm.

When Do I Vote?

Voting by mail is strongly encouraged to protect the public and election workers during the public health emergency. Vote Centers will be open to allow voters to vote in-person or deposit mail-in ballots. In order to minimize lines and reduce the number of individuals in Vote Centers, voters are asked to observe staggered voting using the first letter of their last name.

The first letter of your last name will determine when you are asked to vote. The alphabet has been divided A-L and M-Z. Morning voting (8:30 am – 2:00 pm) is requested where you see “AM” next to the first letter of your last name. Afternoon voting (1:30 pm – 7:00 pm) is requested where you see “PM” next to the first letter of your last name.

Significant Social Distancing will be enforced at all Vote Centers, at all times. The Board will work with other DC Government partners to secure hand sanitizers, masks, gloves, and wipes for the voting equipment. There is no guarantee that we will be able to secure an adequate supply of everything for daily use, but we intend to focus on this goal.

What If I Need Help Voting?

The Board of Elections is committed to ensuring that every voter has equal access to the voting process. The Board's Americans with Disabilities Act (ADA)/Language Access Coordinator is responsible for coordinating the Board's efforts to increase access and encourage participation by voters with disabilities, senior citizens, and limited English proficient voters by providing the following services:

Accessibility and Reasonable Accommodation

All Vote Centers in the District meet strict ADA standards. We offer curbside voting for people with disabilities and people 65 years of age or older. We also designate accessible parking spaces (in instances where parking is provided at the voting location), create accessible routes with well-placed signage, and ensure accessible entrances are properly labeled.

Service dogs¹ are allowed in all Vote Centers. Service dogs must be harnessed, leashed, or tethered, unless these devices interfere with their work or the voter's disability prevents the use of these devices. In that case, the voter must maintain control of the service dog through voice, signal, or other effective controls.

Senior citizens and voters with disabilities may request to remain seated while they wait to be checked-in or vote, as opposed to remaining in line. However, such voters cannot be forced to be seated if they do not wish to be.

Accessible Voting Equipment

All Vote Centers will have Help America Vote Act (HAVA) approved voting equipment, known as Ballot Marking Devices, that will allow voters with disabilities to cast their ballots (and to change their choices before casting their ballots) privately and independently. The Ballot Marking Device was designed to accommodate all voters, including those with cognitive, dexterity, auditory, and visual disabilities. The Ballot Marking Device allows voters to: (1) access the ballot by seeing it on an adjustable touchscreen or by listening to it through audio headphones; (2) mark the ballot using either the touchscreen, a Braille-embossed keypad, a sip & puff device, or a rocker paddle; and (3) switch from English to Spanish.

In addition to accessible voting equipment, our Vote Centers are equipped with auxiliary aids such as magnifying glasses and headphones. Voters may also bring their own assistive devices (headphones, sip & puff devices, rocker paddles, etc.).

¹ Service dogs are individually trained to do work or perform tasks for the benefit of individuals with disabilities.

What If I Need Help With Voting?

Voting Assistance

Voter Assistance Clerks and ADA Compliance Assistants are available to assist with the voting process. In addition, voters may receive assistance with the voting process from anyone they choose (including persons who accompany them to the voting location), other than poll watchers, election observers, their employer or their employer's agent, or an officer or agent of their union. Any individual who assists a voter must complete the List of Assisted Voters Form at the voting location.

Individuals who provide assistance to voters must not try to influence the voter's vote, mark the voter's ballot in a way other than the way the voter requested, or tell anyone how the voter voted.

Language Access Services

Vote Centers will be equipped with in-person and/or video interpreting technology. Voters will have access to over 40 languages, including American Sign Language, language access kits (translated voting information), bilingual election workers, and multilanguage signs/posters.

Election Day Hotline

The Board operates an Election Day hotline dedicated to assisting voters who encounter accessibility and language access issues.

Absentee (Mail-in) Voting

The District offers no-excuse absentee (mail-in) voting by mail for all District residents. See **page 6** of this Guide for more information on the absentee (mail-in) voting process.

A voter who experiences a health crisis after the deadline for requesting an absentee (mail-in) ballot may be eligible to cast an emergency absentee (mail-in) ballot. Please contact the Registrar of Voters at (202) 727-2525 for more information on emergency absentee ballots.

If you need a reasonable accommodation to vote, have questions concerning these services, or would like to receive this information in an alternative language or format (for e.g., Braille, large print), please email the ADA/Language Access Coordinator at tjennings@dcboe.org or call (202) 253-1741 (711 TTY).

Voter Rights and Responsibilities

AS A VOTER IN THE DISTRICT OF COLUMBIA, YOU HAVE THE RIGHT TO:

- be treated with courtesy and respect by election officials;
- register and vote free from discrimination, intimidation, threat, or coercion;
- learn whether your voter registration application has been accepted or rejected;
- receive instructions from election officials on how to cast your ballot;
- inspect a sample ballot and other voting information posted in the polling place;
- bring voter information materials into the voting booth;
- vote privately and independently;
- vote in an accessible polling place with accessible voting equipment;
- receive language access services if you are limited English proficient;
- ask for and receive assistance with voting from anyone you choose (other than a poll watcher, an election observer, your employer, or an officer from your union), including an election worker, if you have a disability, are visually impaired, or cannot read or write;
- have a ballot brought to your vehicle instead of entering the polling place if you are 65 years of age or older, or if you have a disability;
- bring resources inside the polling place that will help you manage your disability, including wheelchairs, canes, walkers, service items, etc.;
- vote a special (provisional) ballot if your eligibility to vote is in question;
- learn whether your special (provisional) ballot was counted and, if not, why not;
- receive up to two (2) replacement ballots if you make a mistake before casting your ballot; and
- vote if you are in line at the time the polls close.

AS A VOTER IN THE DISTRICT OF COLUMBIA, IT IS YOUR RESPONSIBILITY TO:

- treat election workers with courtesy and follow their instructions;
- keep your voter registration information (name, address, party affiliation status) up-to-date with the Board of Elections;
- familiarize yourself with the candidates and measures on the ballot;
- know your polling place location and hours of operation;
- bring the proper documentation with you to the polling place if you are required to show proof of residence;
- make sure you have received the correct ballot before you vote;
- familiarize yourself with the operation of the voting equipment at your polling place;
- respect the privacy of other voters; and
- report any problems or violations of elections laws to the Precinct Captain.

Prohibited Election Practices

In the District of Columbia, it is against the law to:

- make false statements about one's eligibility to register, vote, or hold elective office;
- interfere with a person who is attempting to register or vote;
- bribe or intimidate any voter at an election;
- vote more than once in an election;
- steal or hide votes cast in an election, or obtain, cast, or count false or fake ballots;
- pay, offer to pay, or accept anything of value for registering or voting; or
- obtain or submit false or fake voter registration applications.

Any person found guilty of engaging in illegal activities may be fined up to \$10,000, imprisoned up to five (5) years, or both.

ABSENTEE VOTING INFORMATION

Anyone registered to vote in the District of Columbia can vote by absentee ballot in any election in which they are eligible to vote. If you are not registered to vote, visit www.vote4DC.com for instructions on how to register to vote, or visit the District of Columbia Board of Elections (DCBOE) at the address below.

- **How do I request an absentee ballot?** Fill out this form completely, sign it, and return it to the Board of Elections in person, by mail, by fax at 202.347.2648, or by email in a scanned attachment at DCabsentee@dcboe.org. You can also request an absentee ballot online at www.vote4DC.com.
- **Do I have to use the DCBOE Absentee Ballot Request Form?** No, you are not required to use the Absentee Ballot Request Form to request an absentee ballot - any signed document requesting an absentee ballot is acceptable. Please ensure that your request for an absentee ballot includes the following information:
 - Your name
 - The election(s) for which you are requesting a ballot
 - The address at which you are registered
 - Your current address (*if different from above*)
 - Your contact information (telephone number and/or email address)
 - Your date of birth
 - Mailing address to which the ballot should be sent
 - Your original signature (*A signed absentee ballot request sent electronically will be considered to contain an original signature*)
 - Optional: your telephone number and email address (*while not required, this information will expedite the processing of your request, should we need to contact you*)
- **How will I receive my absentee ballot?** You will receive your absentee ballot by mail at the mailing address you provide on the Absentee Ballot Request Form.
- **How do I vote my absentee ballot?** Complete instructions on how to vote and return your ballot will be included along with your ballot.
- **When must I return my ballot?** Your voted and mailed ballot must be postmarked or otherwise demonstrated to have been sent on or before Election Day, and must arrive no later than the 7th day after Election Day.
