## **I. INTRODUCTION**

D.C. Official Code §1-1001.05(K) and 3 DCMR § 817 mandate that, within 90 days following a general election, the District of Columbia Board of Elections (“BOE” or “Board”) must publish on its website an after-action report containing certain data and information concerning the election. Although it is not required to do so, BOE has consistently provided an after-action report after primary and special elections as well. Accordingly, BOE presents this after-action report (“the Report”) on the June 2, 2020 Primary Election (“the Election”). The Board will post a more comprehensive version of the after-action report on the Election shortly.

## **II. D.C. OFFICIAL CODE §1-1001.05(K)/ 3 DCMR § 817 DATA**

### **A. Ballot Data**

#### **1. Total number of votes cast and counted, broken down by type of ballot, including the number of spoiled and special ballots that were not counted:**

- a. **Total Number of Ballots Cast:** 114,890
- b. **Total Number of Ballots Cast on Election Day:** 20,505
- c. **Total Number of Ballots Cast during Early Voting:** 12,689
- d. **Total Number of Mail Ballots Cast:** 75,929

The Board sent 91,631 mail ballots to domestic voters, and 1,124 mail ballots to voters covered by the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA).

Of the 91,631 domestic mail ballots transmitted:

- 75,567 were returned and counted
- 957 were returned and rejected
- 1,122 were returned as undeliverable
- 7 were spoiled and voided
- 13,978 were neither returned by the voter nor returned as undeliverable

Of the 1,124 UOCAVA ballots transmitted:

- 362 were returned and counted
- 4 were returned and rejected
- 4 were returned as undeliverable
- 754 were neither returned by the voter nor returned as undeliverable

**e. Total Number of Provisional Ballots Cast: 2,484**

Of the 4,988 Provisional Ballots Submitted:

- 2,484 were counted
- 167 were rejected because no proof of residency was provided
- 2,273 were rejected because the ballot voted did not reflect the party of registration on record
- 41 were rejected because the voter had already voted early in person or by mail
- 23 were rejected because the Special Ballot Envelope was not signed
