A. Rulemaking to Amend Title 3 of the D.C. Municipal Regulations

1. Emergency and Proposed Rulemaking
 - a. **BOE** – Chapter 7, "Election Procedures," Chapter 10, "Initiative and Referendum," Chapter 11, "Recall of Elected Officials," Chapter 14, "Candidate Nominations: Political Party Primaries for Presidential Preference and Convention Delegates," Chapter 15, "Candidate Nominations: Electors of President and Vice President of the United States," Chapter 16, "Candidate Nomination: Delegate to the U.S. House Of Representatives, Mayor, Chairman And Members of the Council of the District of Columbia, Attorney General, U.S. Senator, U.S. Representative, Members of the State Board of Education, and Advisory Neighborhood Commissioner," Chapter 17, "Candidates: Members and Officials of Local Committees of Political Parties and National Committee Persons," and Section 9900, "Definitions," of Chapter 99 - The purpose of the amendments to these regulations is to establish regulations consistent with Section 2(a)-(c) of "Initiative 83 - Ranked Choice Voting and Open the Primary Elections to Independent Voters Act of 2024"(D.C. Law 25-295), and to clarify aspects of the nominating petition and ballot measure processing procedures.
 - b. **OCF** - Chapter 30 (Campaign Finance Operations: Committees, Candidates, Constituent Service Programs, Statehood Funds), Chapter 33 (Prohibition on Use of Government Resources for Campaign-Related Purposes and Interpretive Opinions), Chapter 37 (Investigation and Hearings), Chapter 42 (The Fair Elections Program) and Chapter 43 (The Verification Process) – The purpose of these amendments is to place the Office of Campaign Finance's regulations into conformity with the Campaign Finance Reform and Conflict of Interest Public Disclosure Amendment Act of 2011, effective April 27, 2012 (D.C. Law 19-124, 59 DCR 001862 (March 9, 2012)); and the Board of Ethics and Government Accountability Establishment and Comprehensive Ethics Reform Amendment Act of 2011, effective April 27, 2012 (D.C. Law 19-124, 59 DCR 001862 (March 9, 2012)); as amended by the COVID-19 Response

Supplemental Emergency Amendment Act of 2020, effective April 10, 2020 (D.C. Act 23-286; 67 DCR 004178 (April 17, 2020)).
