The D.C. Board of Elections (DCBOE) is sharing important information about the upcoming Special Recall Election for Advisory Neighborhood Commission (ANC) Single Member District (SMD) 6A04. You are receiving this notice because you are eligible to vote if you are still living at this address or within the SMD. Voters will either:

***Vote FOR the recall of Amber Gove, Advisory Neighborhood Commissioner for Single Member District 6A04 (Vote to remove Amber Gove from office for the remainder of the 2021-2022 term).***

***or***

***Vote AGAINST the recall of Amber Gove, Advisory Neighborhood Commissioner for Single Member District 6A04 (Vote to keep Amber Gove in office for the remainder of the 2021-2022 term).***

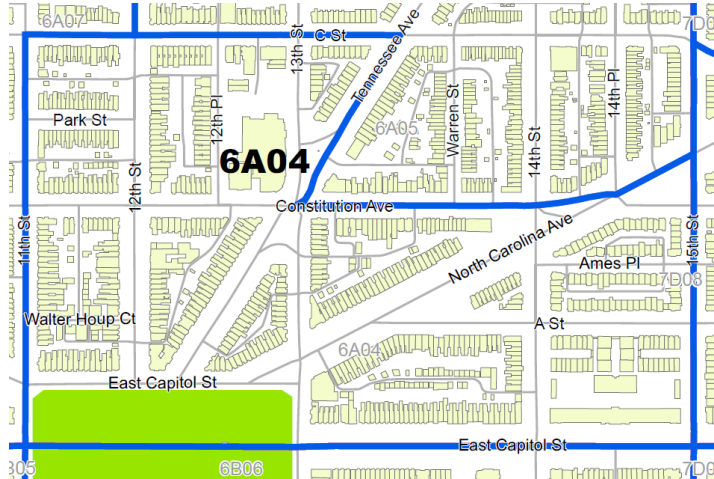

All voters living within the boundaries of this map are eligible to vote in the Special Recall Election.

The impacted blocks are:

Warren Street, 14<sup>th</sup> Street, and 14<sup>th</sup> Place between C Street and Constitution Avenue

North side of Constitution Avenue between Tennessee Avenue and 14<sup>th</sup> Place

North side of North Carolina Avenue from 14<sup>th</sup> Place to 15<sup>th</sup> Street

West side of 15<sup>th</sup> Street between North Carolina Avenue and C Street

South side of C Street between Tennessee Avenue and 15<sup>th</sup> Street

East side of Tennessee Avenue between Constitution Avenue and C Street
