## LUNCH AND LEARN FOR CANDIDATES, PROPONENTS OF BALLOT MEASURES, AND PETITION CIRCULATORS

The DC Board of Elections Voter Services Division will conduct virtual training sessions for candidates, ballot measure proponents, and petition circulators. The sessions will provide an overview of the Board's guidelines and policies for circulating nominating and ballot measure petitions. Attendees will also be able to ask questions about the process and access additional resources.
