**RE: Vacancy in SMD 2B09**

Dear Mayor Bowser, Chairman Mendelson, Chairman Thompson, and Mr. Davis,

At a special meeting on September 3, 2025, the Dupont Circle Advisory Neighborhood Commission (“ANC 2B” or “Commission”) considered the above-referenced matter. With 8 of 9 Commissioners in attendance, a quorum at a duly-noticed public meeting, the Commission approved the following resolution by a vote of (8-0-0):

**Whereas** Commissioner Christopher Davis (2B09) announced his resignation from ANC via his public X account on July 25<sup>th</sup>,

**Whereas** Commissioner Davis verbally reiterated his intention to resign the following week, and did not attend the regularly scheduled meeting in August,

**Whereas** Commissioner Davis has not responded to any subsequent communications from Commission 2B or OANC pertaining to this announcement, nor has he filed the necessary resignation paperwork with the Board of Elections,

**Whereas** this failure to communicate or respond to requests to clarify his intentions is cause for great concern as to his ability to discharge the duties of a Commissioner,

**And Whereas** Commissioner Davis was sent notice of this meeting via certified mail 15 days ago, as required by DC Code 1-309.06 (f) (2),

**Be it resolved** that ANC 2B requests the Board of Elections declare SMD 2B09 vacant.

Commissioner Adams ([2B08@anc.dc.gov](mailto:2B08@anc.dc.gov)) and Commissioner Franklin ([2B07@anc.dc.gov](mailto:2B07@anc.dc.gov)) are the Commission's representatives in this matter.
