### GUIDELINES FOR POLL WATCHERS & ELECTION OBSERVERS IN THE VOTE CENTER

**Poll Watchers** are individuals designated by a candidate or campaign to observe the election process. **Election Observers** are individuals who wish to observe the election process, but are not designated by a candidate or campaign to serve as Poll Watchers. The DC Board of Elections (DCBOE) provides these Guidelines for Poll Watchers & Election Observers in order to ensure the orderly conduct of elections and to protect the rights of all participants in the voting process.

Site Coordinators are asked to make every reasonable effort to accommodate Poll Watchers and Election Observers. Priority accommodation is given first to Poll Watchers (*1 Watcher per Vote Center per campaign at any given time*), and then to members of the media and Election Observers. Site Coordinators have the authority to regulate the presence and activities of Poll Watchers and Election Observers within the Vote Center, including limiting the number of Poll Watchers and Election Observers at one time and ejecting disruptive individuals.

#### **Poll Watchers & Election Observers must:**

- ❖ Sign in and out on the Sign-in Sheet whenever entering and/or leaving the Vote Center.
- ❖ Visibly wear a badge issued by the DCBOE at all times while in the Vote Center that indicates:
  - The name of the candidate or group represented (if any); and
  - The Poll Watcher/Election Observer's name.
- ❖ Direct any questions to the Site Coordinator or any other election worker(s) designated.
- ❖ Follow the instructions of the Site Coordinator and remain within any designated area within the Vote Center.

#### **Poll Watchers & Election Observers may:**

- ❖ Observe the election process, including the opening and closing procedures for the voting equipment and the Special Ballot Box.
- ❖ Unofficially ascertain the identity of persons who have voted.
- ❖ Report any alleged election discrepancies to the Site Coordinator.
- ❖ Ask questions about the election process to the Site Coordinator and listen to conversations between election workers and voters.

#### **Poll Watchers & Election Observers may not:**

- ❖ Touch any official record, ballot, voting equipment, or counting form.
- ❖ Wear any campaign paraphernalia or hand out any campaign literature.
- ❖ Talk to voters who are in the process of checking in or casting their ballots.
- ❖ Urge the election or defeat of any candidate or measure on the ballot.
- ❖ Interfere with Vote Center officials or obstruct the election process.
- ❖ Compromise the secrecy of a voter's ballot.
- ❖ Talk on cell phones. With the exception that silent communication by text message and email is permissible.
- ❖ Provide assistance to voters.
- ❖ Take any videos or pictures while inside voting or counting areas, if such use is determined by the election officials to be disruptive or interfere with the process.

**Please remember that candidates cannot serve as Poll Watchers.**
